II. PRESENTATION OF THE ASSOCIATION

“Pari sur l’enfance” could be translated as “Invest in the future, invest in the children”.

It is a nonprofit association created under the French law of July 1st, 1901 to support orphans and child beggars.

“Pari sur l’enfance” will spare no effort to help each child:



Have a safe place to live in



Be protected



Be surrounded by people who care about and take care of him/her



Have a good alimentation



Have a good education



Have decent clothes



Have access to health care: prevention and treatment

This addresses real challenges in a child’s life.

Challenge can mean “Pari” in French and child’s life means “enfance”. So, this fits perfectly with the association’s name: **“PARI SUR L’ENFANCE”**.

II.1. LOGO

The logo has been created based on the will above: help each child get his/her fundamental needs.



A silhouette has been chosen to reflect each child regardless of his/her origin.

II.2. ASSOCIATION BENEFICIARIES

“Pari sur l’enfance” will take its first actions in Senegal.

As soon as the association gets the necessary funds to assist more countries, necessary means will be deployed to help more orphans and child beggars.

Please find below the structures with which we are partnering.

❖ Orphans

In order to assist children efficiently in terms of food, education and health; but above all, in order to help the beneficiary structures get a financial autonomy, “Pari sur l’enfance” will work with one orphanage at the beginning. We aim to support at least one more each year.



The partnered structure is the following one.

Orphanage “Sourire bébé”

Created in June 2016, the orphanage takes care of low and middle age babies but also children with a mental illness.

Only in one year, the structure became known for its reliability and its commitment.

Despite the lack of financial and material resources, the orphanage founder Mrs. Bineta Fatim Dieng spares no effort to assist each child.

However, needs are constantly growing and meeting them is more and more difficult.

Some donations could help go through difficulties.

The child education also concerns Mrs Dieng. Her goal is to help each of the children have a good education to pretend to a good future and become independent later.



❖ Child beggars

The phenomenon of child begging is spreading more and more in the world.

Many are the young people aged between 5 and 15 who roam the streets. The consequences are more than significant: hunger, bad living conditions, a compromised education, a future probably not promising, etc.

In Senegal, most child beggars live in sites called “daaras”. They are sent there by parents to get a religious education.

There are three categories of “daaras” and “Pari sur l’enfance” aims to support the last two.

➤ **Category 1: structured “daaras” -- financially stable**

They are the boarding schools that receive remuneration for the children’s education and needs. These “daaras” are financially stable and children in there do not beg.

➤ **Category 2: non-structured “daaras” – more or less financially stable and may need additional aid**

“Daaras” in this category don’t receive any (or almost any) compensation or remuneration. All children’s needs are supported by people who run the “daaras”.

Most children in there come from modest families.

They do not beg but their living conditions are not easy. Some donations could help go through difficulties.

➤ **Category 3: Non-structured “daaras” – not financially stable**

The people who run these “daaras” host, where they live, children sent by parents. Due to their modest or null incomes, parents don’t give remuneration for their child education.

Because these “daaras” are hosted in the houses of those who run them, they are non-structured. The consequence is that they are not known. So, they do not receive any aid.

As they don’t have enough resources to meet the children’s needs, those who run the “daaras” send the children to beg.

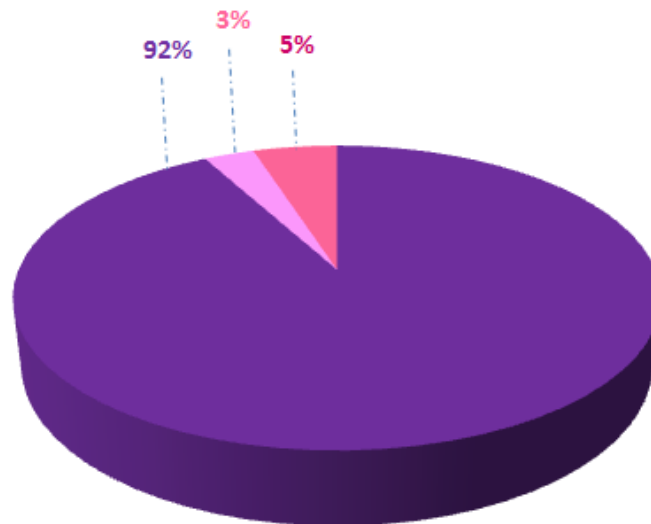
Currently, “Pari sur l’enfance” is supporting the last two categories. One “daara” has been chosen in the category 2 and three others in the category 3.

We aim to help at least one more each year.



II.3. DONATION DISTRIBUTION

92% of donations will go to orphans and child beggars.
3% will cover the association's administrative charges.
5% will help support social projects.



Regarding the social projects, many children are neither orphans nor beggars but face difficulties in terms of food, education, medical care, etc.

In order to help the maximum of children meet their basic needs, "Pari sur l'enfance" will use a part of the donations to help support social projects.

Every month, an **activity report** on donations provided to beneficiaries will be **published** on the association website.



III. GOALS OF THE ASSOCIATION

Child beggars and orphans certainly do not have an easy childhood, but as Graham Greene said:

"There is always one moment in childhood when the door opens and lets the future in."

Convinced that we all can participate in the opening of that door and help these children have a better future, the "Pari sur l'enfance" association has been created.

Three goals were set:

❖ **First goal: Provide basic needs**

This includes food, health care and clothing.

Mattresses and blankets will be provided too. Walking unshod all day with an empty stomach and dirty clothes and then coming home to sleep on a mat would be a hard thing to do for the most of us; but that's how most child beggars spend their days.

❖ **Second goal: Support child education**

- Regarding orphans, "Pari sur l'enfance" will ensure that children at the relevant age to start kindergarten, pre-school or school will be registered and provided with educational materials.

Our finances will not allow us to register all children in private schools. However, we guarantee that they will go to good establishments selected with the greatest respect of the children's right to a good education.

If the distance between the school and the orphanage is too far, transport costs will be provided by the association.

- Regarding child beggars, their insertion in school will be a bit more complicated. Indeed, most children have already surpassed the age to attend school. In this case, we will try to find a solution, together with the people responsible for them, to help children have a vocational training: e.g. carpentry, masonry, plumbing, IT, etc.

Children with a non-advanced age will be registered at school.

❖ **Third goal: Thanks to secure projects, promote the financial autonomy of orphanages and sites where child beggars live**

Because supporting them is helping them become financially independent, "Pari sur l'enfance" will help its beneficiaries launch and develop their own projects.

The association will then provide zero-rated microcredits.

The reimbursement will be in long-term and adapted to the situation of each beneficiary.

The amount reimbursed will be used to help other orphans and child beggars.

Important: each of these projects will be attentively directed by the association team to ensure the good management but specially to make sure that the benefits will be used for the child beggars and orphans needs.



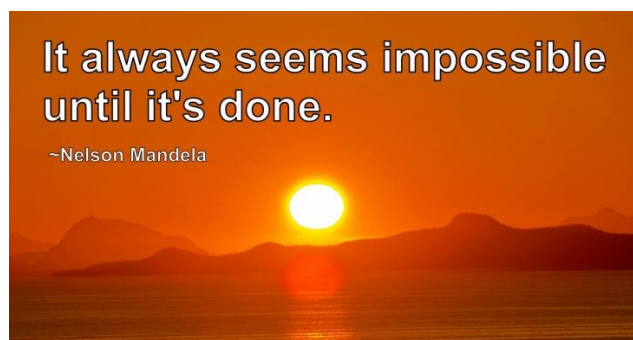
Just like those associations which exist for more than 30 years, we aim to sustain "Pari sur l'enfance" to quantitatively and qualitatively improve the aid granted.

❖ **PayPal or credit card**

Two bank accounts are available for the moment: one in France and one in Senegal.

Please, don't hesitate to choose regular transfers (to the possible extent). That will help sustain our actions.

❖ **In-kind donation**

As we currently lack the means to bring items from abroad to Senegal, material aids can be received only in Senegal.

Donations can also be sent via Orange Money.

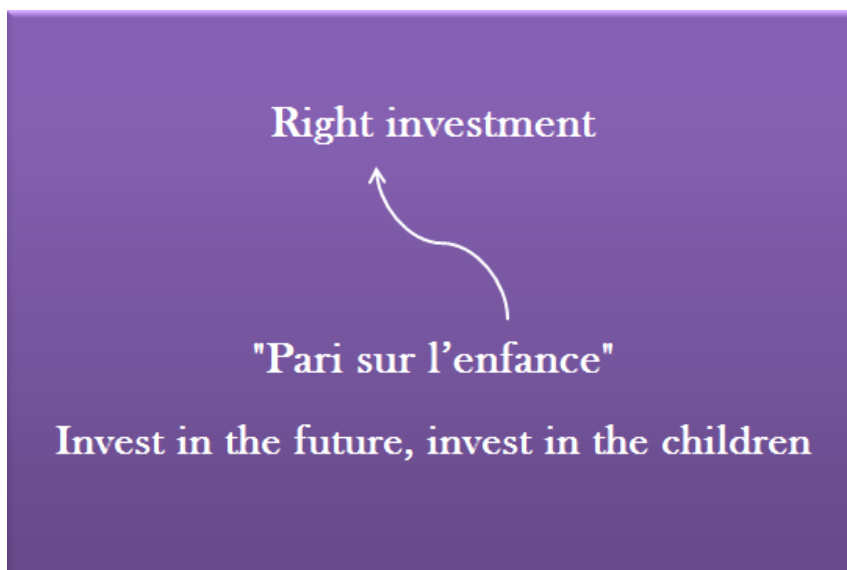
